ANNOUNCEMENT ON QUARTERLY REVIEW ON CONTINUING CONNECTED TRANSACTIONS

The Company and CSRG entered into a mutual supply framework agreement on 28 April 2008 and a supplemental agreement thereto on 14 April 2009 for the mutual supply of certain products, facilities and after-sales services between the Group and the CSRG Group, details of which were set out in the Announcement and the Circular.

CSRG is a connected person of the Company and the aforesaid mutual supply transactions between the Group and the CSRG Group constitute continuing connected transactions of the Company under the Listing Rules. In order to protect the interests of the Company’s independent shareholders, the Company has adopted a series of corporate governance measures including, but not limited to, the review by the independent non-executive directors of the Company on a quarterly basis of the terms of such mutual supply transactions and the disclosure of their view in respect of such transactions to the Company’s shareholders by way of an announcement.

The independent non-executive directors of the Company considered that, for the fourth quarter ended 31 December 2010, the relevant transactions were entered into in the ordinary and usual course of business of the Group; were on normal commercial terms which were fair and reasonable insofar as the interests of the Company and its shareholders as a whole are concerned; were conducted in accordance with the Group’s pricing policies and the terms of the relevant agreements governing such transactions; and were within the annual cap amounts of 2010 set out in the Circular.

Reference is made to the announcement dated 14 April 2009 (the “**Announcement**”) and the circular dated 5 May 2009 (the “**Circular**”) issued by Zhuzhou CSR Times Electric Co., Ltd. (the “**Company**”, together with its subsidiaries, the “**Group**”).

The Company and CSR Corporation Limited (Formerly known as China South Locomotive & Rolling Stock Corporation Limited) (“**CSRG**”, together with its subsidiaries but excluding the Group, the “**CSRG Group**”) entered into a mutual supply framework agreement on 28 April 2008 and a supplemental agreement thereto on 14 April 2009 for the mutual supply of certain products, facilities and after-sales services between the Group and the CSRG Group for a term of five years commenced on 1 January 2009 and ending on 31 December 2013. Details of such mutual supply transactions were set out in the Announcement and the Circular.

CSRG is a connected person of the Company and the aforesaid mutual supply transactions between the Group and the CSRG Group constitute continuing connected transactions of the Company under the Rules Governing the Listing of Securities on the Stock Exchange (the “**Listing Rules**”), and are subject to the reporting, announcement and independent shareholders’ approval requirements set out in Rules 14A.45 to 14A.48 of the Listing Rules. The relevant independent shareholders’ approval was obtained by the Company at its extraordinary general meeting held on 23 June 2009.

In order to protect the interests of the Company’s independent shareholders, the Company has adopted a series of corporate governance measures including, but not limited to, the review by the independent non-executive directors of the Company on a quarterly basis of the terms of the aforesaid mutual supply transactions and the disclosure of their view in respect of such transactions to the Company’s shareholders by way of an announcement.

The independent non-executive directors of the Company considered that, for the fourth quarter ended 31 December 2010, the relevant transactions:

- (1) were entered into in the ordinary and usual course of business of the Group;
- (2) were on normal commercial terms which were fair and reasonable insofar as the interests of the Company and its shareholders as a whole are concerned;
- (3) were conducted in accordance with the Group’s pricing policies and the terms of the relevant agreements governing such transactions; and
- (4) were within the annual cap amounts of 2010 set out in the Circular.
